• There is inaccuracy within the application in relation to the height of the fence both as is and as proposed - the fence has already been raised to the proposed height along the A417 - the 'proposed' fence height of 1800mm (as in situ) sited on top of the raised garden gives the appearance of a 'secure unit' not a supported living complex as is the description of the business.

Anthony Scragg has put a notice on the shed.

Ongoing, the verge at the north end is being prepared for seeding.

j. Hedges.

Hedge letters have been sent to two residents, further letters to be sent to 6, Church Rise, Wheelers Cottage and the pub.

k. Churchyard Maintenance.

*After some debate a compromise solution was reached - essentially:* 

a] it was agreed that there should be a "unmaintained" ecological section of the main churchyard (despite the vociferous opposition of one individual who argued the PCC had already decided to merely allow a part of the overflow graveyard to be thus used);

*b*] it was crucially agreed that the area selected would not include any gravestones (this was a significant sticking point for many despite, curiously, the opinions of the vicar!)

c] it was agreed that a sinuous strip up the entire eastern side of the churchyard would be phase 1 - approx as shown on my attached markup

d] it was agreed there would be a mown strip adjacent to the hedges to avoid the two coalescing and to enable proper maintenance

*e]* it was agreed that part of this area would be "type 1" with topsoil removal and part "type 2" with just controlled mowing. The topsoil removal would only be about 2" not the 4-6" noted in the previous report

*f*] it was agreed that Andrew Cooley would revise the proposals to create an implementation proposal and meet with Jeremy Chamberlayne and the Finches to arrange installation by

*Spring 2020 - Jeremy will be providing a mini-digger for the invasive works and disposing of the topsoil resulting*
